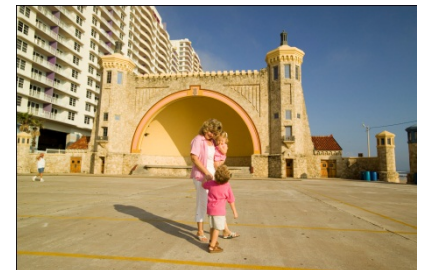

There are standard room rentals and set-up charges that apply to all functions. Rooms are rented in three (3) hour increments. You are also guaranteed one (1) hour prior to function for all deliveries and set-up requirements. A charge of \$150.00 will be assessed for each additional hour.

Bar & Beverage

Cash or open bars are done according the specifications of the specific tenant caterer that you select. Most serve beer/wine and several offer specialty cocktails and a full liquor bar. The Ocean View Room can assist you with determining an estimate for the bar based on the product the you wish to be made available. Please note that each tenant caterer may have their own service charge for bartender services.

Outside Food & Beverage

Due to Health Department and Alcohol Beverage Control Laws and Regulations, outside food and beverage are not permitted, with the exception of Celebration cakes.

Alcohol Beverage Service

As a licensee of the State of Alcoholic Beverage Control Authority, the Ocean View Room strictly adheres to all laws and regulations pertaining to service and sale of alcoholic beverages. We ask your understanding and must insist upon your corporation in preventing sales to minor and/or intoxicated persons.



Decorations

All table centerpieces and other decorations must meet fire and safety codes and regulations. In addition, the Ocean View Room does not permit anything to be affixed to the walls, ceilings, furniture, fixtures, furnishings or any other property unless Management gives prior approval. In the event any of the foregoing is done without authorizations, the person and/or company responsible for the function will pay the cost of any repair and/or damage to the property. Removal of all decorations is the responsibility of the client. Removal of all items must be done at the end of the event.

Security

The Ocean View Room at its discretion may require security for certain events. The cost of these services will be the responsibility of the client.

Loss and Damage

The Ocean View Room, Ocean Walk Movies 10, or Ocean Walk Shoppes is not responsible for any damages or loss of any merchandise or articles left prior to, during or after any event. The client agrees to be responsible for any damages to Ocean Walk property by the client, guests and/or attendees of the event.

Cancellation Policy

All Reservation Fees and Deposits are non-refundable if the event is cancelled. Cancellations must be made in writing, and any events cancelled less than thirty (30) days prior to the event may incur an additional \$150 cancellation fee.

Tax & Service Charge

County Sales Tax of 6.5% will be added to all charges.

Restrictions

Bird Seed, Rice, Confetti, Glitter, Fog Machines and Sparklers are not permitted on property. Additional charges will be assessed to all groups failing to comply with this policy. Bubbles and Rose Petals may be used in outside area only. There is absolutely no smoking permitted in Ocean View Room.

Approved Vendors

All vendors on our Approved Vendor List are experienced and trusted entertainment professionals, ensuring your event go smoothly. Vendors not listed may be approved on an individual basis with advance written approval by Ocean Walk Shoppes, prior to contract signing.

Fees

A deposit of 80% of contract amount is due at acceptance of this Agreement. The balance of the contract amount shall be due and payable before setup of the event, or applied to master bill at resort. Payments received after such dates shall incur additional charges of 20% of the outstanding balance if not paid within 7 days of event. Thereafter, interest on unpaid amounts shall accrue at the monthly rate of 1.5%. Payment of charges in excess of the estimate is due the day of the function when the invoice is presented. Acceptable forms of payment are cash, cashier's check, money order, or personal check.
